PMC clients include major international Jamaican recording artists and songwriters such as Derrick Morgan and Alton Ellis.

Trials

In the course of Mark's work as a barrister and as a recognised trade mark lawyer he has represented large corporations protecting IP rights such as **Pfizer**. Mark was instructed as lead counsel for the prosecution in two major trials spanning four years concerning an international fraud in illicit copies of Microsoft software working closely with the National Crime Squad, the FBI and the Texas Attorney General's Office.

Mark's work affords him an international perspective on practical rights protection, enforcement and development.

Musician

Mark is a musician and composer who as a child was trained as a chorister and classical musician and whose love of jazz and ska music resulted in playing with, inter alia, '2Tone' legends **Bad Manners**.

Mark is the founder of Club Ska Records, Films and Promotions and has produced numerous albums including 'Ruts in a Can' and 'Laurel Aitken - Live at Club Ska' and commercially released Music DVD's including '45 Revolutions Per Minute'. Mark has also worked closely with the BBC on several music documentaries.
